### July 1 Marks Shift in Georgia Agencies Regulating Health Care Licensees

On July 1, 2009, the Georgia Department of Human Resources ("DHR") became known as the Georgia Department of Human Services ("DHS"). Simultaneously, certain services that had been provided by DHR, such as the licensure of Georgia health care facilities, shifted to the Georgia Department of Community Health ("DCH").

DCH already serves as the lead agency for health care planning in Georgia and is also designated as the single state agency for Medicaid. To further complement these services, DCH will now also perform licensure-related duties. The newly created division of DCH that governs health care facility regulation is known as the "Health Care Facility Regulation Division." It is divided as follows:

- Complaint/Intake Section which is overseen by Deputy Chief Leslie Poole and is further divided into two sections: (1) Operations and (2) Investigations and Complaints.
- Survey/Certification Section which is overseen by Deputy Chief Sharon King and is further divided into the following sections: (1) Long-Term Care, (2) Health Care, (3) Waivers, (4) Home Health, and (5) Personal Care.

DHS, as its new name suggests, provides human services such as economic assistance programs, child and adult protective services, enforcement for child support, and foster care programs. Divisions within DHS include the Division of Family and Children Services, the Division of Aging Services, the Office of Child Support Services, the Office of Residential Child Care, and additional support offices. Effective July 1, 2009, Georgia also has a new agency, the Georgia Department of Behavioral Health & Developmental Disabilities ("DBHDD"). DBHDD provides treatment and support services to people with mental illnesses and addictive diseases as well as support for those with mental retardation and related developmental disabilities. The Office of Prevention Services and Programs, which had been a part of DHR and was for a short time located in the Division of Public Health, is now part of DBHDD.
